Malang Regency is a district located in the top 3 with the highest occurrences of criminal crime in East Java after Surabaya and Sidoarjo. The highest crime that occurred in Malang was theft with weighting. Every year, the number of criminal thefts is always the highest in the category of crime that occurs in Malang Regency, with the amount always touching hundreds or more. Events This makes the act criminal theft with weighting including one of act deep criminal handling must live with proper procedure use enlarge percentage disclosure act criminal nozzle For achievement task central police that is enforcement law.

Based on crime data and prominent events that occurred in Malang Regency, it can concluded that the highest crime that happened in the period 3 years is theft with weighting. Of course, This will become a problem for police, especially investigators at Malang Police, with the number percentage of solutions. With the rate, the solution is still low compared to other crimes; it can be concluded that an adequate investigation has not yet been conducted, especially in the increased percentage of successful disclosures of criminal theft in the jurisdiction of Malang Police. Based on the article, the perpetrator acts criminal theft with a weighting charged punishment of prison maximum of 9 years.

Article 13 explains the related tasks as a member of the Indonesian National Police, including:
